- 4. Dogs must be on a non-retractable leash and must not be "in season".
- 5. Escorts are encouraged to join in the theme with costumes, music, and floats. Floats can be made out of wagons, baby strollers, shopping carts, bicycles, golf carts, etc.
- 6. Escorts are strongly encouraged to have a ready supply of throws.
- 7. Escorts are deemed "Official Pooper Scoopers" (there will be plenty of bags available and disposal locations).
- 8. All minors must be accompanies by an adult.

Waiver and Release of Liability (please read and sign):
